## GENERAL TERMS OF PARTICIPATION IN THE EXHIBITION

By "BolognaFiere" we mean: BolognaFiere S.p.A. with registered office in Bologna (Italy), Viale della Fiera no. 20.  
By "Organizer" we mean: CONFERENCE SERVICE srl with registered office in Bologna ITALY, Via de' Buttieri no. 5/4.

### Art. 1 - ADMISSION TO THE EXHIBITION -

The following may be admitted as Exhibitors:  
a) Italian and foreign firms own products or services belonging to the classes of products pertaining to this exhibition. If the manufacturing companies do not take part in the exhibition, their exclusive or general concessionaires, agents, or representatives may be admitted.

b) Trade Unions, Public Bodies, and Organisations that by statute carry out activities of promotion, study, information, and promotion in the sectors covered by the exhibition.

The Organizer reserves the right to also admit Firms, Bodies, and Organisations not included in the previous paragraphs, and to exclude from the exhibition certain services, products or samples.

**Art. 2 - PARTICIPATION IN THE EXHIBITION** - The application for participation must be duly filled in on a special form, undersigned, countersigned, and sent, under penalty of invalidity. It will be considered an irrevocable proposal by the applicant and will imply his full acceptance of these "General Terms" as well as of the "Exhibition Technical Regulations and Various Forms Folder", of the "Exhibition Centre Regulations", and any other rule relating to the organisation and operation of the Exhibition and the Exhibition Centre). Failure to send the application for participation on the Application Form established by the Organizer will lead the exclusion of the application.

The Organizer will decide on the admission independently and with the sole obligation of stating the reasons for refusal only for applications received by the Organisation at least 60 days before the opening date of the Exhibition, so long as the applicant submits a formal request within 30 days after the end of the Exhibition.

Exclusive or general concessionaires, representatives and agents must enclose with their application a list of the manufacturers represented by them as well as the products they intend to exhibit, together with the agency and/or representation contract. The presentation of the same products or samples belonging to the same company is forbidden in more than one stand of the same marketing sector.

The applicant is obliged to supply any other documentation that may be required for a decision to be made as to whether his application is to be accepted, and to ascertain at all times compliance with the terms of participation in the exhibition.

**Art. 3 - ADMISSION FEE, PARTICIPATION FEE AND CAUTION MONEY** - a) The Admission Fee is fixed at € 500.00 and shall be paid also in the event of not location of the exhibition spaces, which rate is settled as from Participation Fee section. b) The Participation Fee is fixed at € 170.00 per square metre. Reduced Participation Fees fixed at € 145.00/sq.m. and € 160.00/sq.m. will apply on registrations sent along with caution money respectively by 31/07/2009 and 31/10/2009. For corner positions and/or aisle positions a rise of 15% on the entire exhibiting area will be applied.

Exhibitors who also represent other companies or promote the image of other companies must, in addition, pay a Registration Fee of € 100.00 for each company represented or whose products, services or image are promoted or displayed. Should a not-registered company be found to be displaying or promoting its products or services the Exhibitor shall pay a sum equal to that of the Admission Fee i.e. € 500.00 per company not registered. Together with the application form Exhibitors must pay 50% of the sum due in the form of caution money otherwise the applicant will be excluded from the exhibition. If the application is rejected, the caution money will be refunded.

**Art. 4 - TERMS OF PAYMENT** - The applicant must pay the balance due by 31st January 2010. Otherwise, the Organizer may consider the contract terminated by default, without it being necessary to send any formal warning or have a ruling issued by a law court. In this case, the Organizer will inform the party concerned. The Organizer will be free from any obligation and free to dispose of the stand in any way he wishes by assigning it to other applicants. The Organizer will be entitled to receive full payment by the defaulting Exhibitor of the registration and participation fees as a penalty, and of all other contractual fees, having deducted the sums paid in advance and without prejudice to his right to compensation for greater damages. If, on the other hand, the Organizer intends to respect the contractual obligation with the applicant, he may demand from the latter full payment of the registration and participation fees, increased by the Official Discount Rate plus three points as conventional interest and interest for delayed payment, at the settlement date of 31st January 2010.

**Art. 5 - STANDS ASSIGNMENT** - The assignment of stands exclusively and autonomously belongs to the Organizer. Any special request by the Exhibitor when the application form is submitted shall be considered purely indicative and by no means binding on the Organizer, nor shall it in any way effect his application for participation and hence shall be considered as not submitted. The Organizer reserves the right to assign stands that do not appear on the floor plan.

The Organizer reserves the irrevocable right, for either technical and organizational purposes, to move or reduce the allocated stand and may even transfer it to a different area, when necessary, without the participant having any right to allowances, indemnities or compensations for any reason whatsoever. The Organizer shall notify the participant of the above. The date of consignment of the stand shall be the one specified in the "Exhibition Technical Regulations".

**Art. 6 - WITHDRAWAL FACILITY** - A participant held from participating in the exhibition for a legitimate and demonstrated reason may withdraw from the contract. In this event he/she must inform the Organizer by registered letter at least 60 days before the exhibition opening date, without prejudice to the Organizer's right to appropriate the caution money and any further right to compensation for possible greater damage. If this notice is given less than 60 days before the beginning of the exhibition, besides caution money, the participant will also be obliged to pay the entire amount due, without prejudice to the right to claim further direct or indirect damages. In this event, the Organizer may dispose of the stand as he wishes, and also assign it to other Exhibitors.

The Organizer has the right to judge the reasons preventing the participant from taking part in the exhibition. If the Exhibitor fails to give communication of withdrawal and fails to set up his stand within the time fixed in the "Exhibition Technical Regulations", he will be considered in default to all intents and purposes, and besides having to pay the entire amount due, he shall also be obliged to refund direct and indirect damages suffered by the Organizer. Also in this event, the Organizer may still dispose of the stand as he wishes and assign it to other Exhibitors.

The Organizer may withdraw from the participation contract at his discretion up to two weeks before the opening of the exhibition, and for reasons relating to the organisation of the exhibition up to the opening date. In this event, the Organizer shall not be obliged to indemnify or compensate the participant in any way, but he shall have to refund any amounts already received.

**Art. 7 - CONSIGNMENT OF THE STAND** - The stands will be made available to Exhibitors according to the terms specified in the "Exhibition Technical Regulations". They shall be completed within the time specified in the "Exhibition Technical Regulations". Failing this, the contract could be terminated for non-fulfilment of the participant in the same manner and with the same consequences as provided in art. 6.

**Art. 8 - STAND FITTING** - The stands must be contained within the allocated area, as better indicated in the "Exhibition Technical Regulations"; moreover, they must not exceed the maximum allowed height as specified in the "Exhibition Technical Regulations". It is prohibited to build accessible footboards in excess of a height of 0.70 m.

Stands and installations must be built in a professional manner and in compliance with accident and fire prevention regulations. As regards projects for stands which by extent, size, or characteristics are outside traditional standards (only for those for which approval of exhibition spaces has been obtained), the Exhibitor is obliged to obtain the approval of the Organizer and the BolognaFiere Operations Division, and to submit technical drawings and the names of engineers responsible for the structural parts, set-up and systems at least 120 days before the beginning of the event; the same obligation is applicable to stands, constructions, pavilions, and structures erected in external areas. BolognaFiere shall be entitled to request the intervention of the Supervisory Committee for public entertainment premises. The Exhibitor shall take due note that the Exhibition Centre is assimilated to entertainment premises and he undertakes to abide by the law and all the provisions and formalities provided for in the "Exhibition Technical Regulations and Various Forms Folder".

Failure to hand in to BolognaFiere the statements and documentation mentioned in the "Exhibition Technical Regulations and Various Forms Folder" and concerning liability as far as stands, electric plants, and specialty systems for fire prevention are concerned, will entitle BolognaFiere to close the stand and adopt the most appropriate measures to ensure that safety conditions are met, without prejudice to the civil and criminal liability of the Exhibitor.

BolognaFiere reserves the right to change or renovate the stands and installations that do not meet the above-mentioned requirements. All liability as to the static of the stands, execution, and operation of the systems and regarding any damage to persons or things owned by BolognaFiere or third parties exclusively belongs to the Exhibitor.

Failure to comply with these regulations and with others on the same subject contained in the Participation Regulations entitles BolognaFiere to take precautionary measures against companies not compliant with fire prevention regulations. In the event that additional measures to general safety conditions are adopted, this may lead to charging the relevant expenses calculated to be not less than 300.00 Euro per module or to order the partial or total take down of the stand and to the declaration of its unsuitability for access or use. Non-compliance with the safety rules may lead to a report to the judicial authorities.

**Art. 9 - RETURN OF STANDS** - At the end of the exhibition, but not before, Exhibitors must dismantle the products and materials they have installed and, after obtaining the exit pass from the organizer, shall remove them from the Exhibition Centre. The above mentioned exit pass shall not be given to those Exhibitors who have not settled their payments, either directly or indirectly, with the Organizer. Nevertheless, it will not represent a receipt of payment of any sums due for participation in the exhibition and will be valid only for the vehicle specified on the pass.

Stands must be cleared by the date indicated in the "Exhibition Technical Regulations". After the above mentioned term, the stand will be dismantled and cleared by BolognaFiere and all materials left at the stand will be considered waste to be sent to public dumps. The Exhibitor will be required to reimburse BolognaFiere for all direct and indirect expenses incurred for such activities, and will be charged a penalty of € 300.00 plus any additional damages suffered.

The participant expressly authorises the Organizer to check that the products or materials being taken out of the Exhibition Centre in the Exhibitor's vehicles or packaging are not different from those installed in the stand and listed in the exit voucher, and authorises the Organizer to stop the products or materials not listed in the voucher from being taken out. The Organizer and BolognaFiere decline all liability for goods, materials, and other properties left unattended by Exhibitors within the Exhibition Centre.

**Art. 10 - ACCESS TO THE EXHIBITION CENTRE** - The exhibition is open to visitors carrying the requisite entry documents, at the fixed price of € 20 per day and € 35 two days ticket, every day at the times which the Organizer reserves the right to establish, and if necessary, to change, even during the exhibition. In order to allow free access to the Exhibition to Exhibitors and their personnel, the Organizer shall issue special passes as described in the "Exhibition Technical Regulations and Various Forms Folder". The use of these passes implies that they are accepted.

For all intents and purposes the Exhibitor is liable for the behaviour of persons using the free entry pass given by the Organizer, as well as for the behaviour of his employees, assistants, and collaborators in the fulfilment of the tasks assigned to them. It is strictly forbidden to promote offers or oblations for recognised institutions, to collect alms, to make political, religious, or partisan propaganda, or to carry out any activity not falling within the purpose of the Exhibition within the Exhibition Centre.

### Art. 11 - SURVEILLANCE AGAINST THEFTS - LIABILITY FOR THEFTS AND DAMAGES - BOLOGNAFIERE'S EXEMPTION

**FROM LIABILITY** - During exhibition opening hours, the Exhibitor must watch over his stand directly or through his staff.

Though BolognaFiere provides a general night and day watch service inside the Exhibition Centre on all the stands during setting-up, exhibition and dismantling days, it declines all and any liability as regards thefts and/or damages that should occur to the detriment of the Exhibitor. The Exhibitor shall also be liable towards BolognaFiere for all direct and indirect damages that due to his or his staff fault (including damages caused by the stands or the systems installed by the Exhibitor or his appointed third parties, even if approved by BolognaFiere).

**Art. 12 - INSURANCE - EXEMPTIONS AND UNDERTAKING OF LIABILITY** - The Exhibitor will benefit from the following insurance policies drawn up by the Organizer:

a) All Risks guarantee (including fire and theft) for material and direct damage to furniture, fittings, equipment, and goods in the stand, except money, valuables, jewels, and similar items and excluding the software installed on computers and the damages by missed use of the furnishings, of the preparation, of the equipments and the commodities during the Exhibition - cover € 26,000.00 on the first annual risk.

b) Exhibitor's Third Party Liability guarantee: one maximum insurable sum € 1,600,000.00.

c) Exhibitor's Employees Liability guarantee: one maximum insurable sum € 520,000.00

The above insurance covers are governed by the conditions and limitations that the Exhibitor may request to the Organizer, and are specified in the relevant form contained in the Various Forms Folder. These covers do not exclude the liability of the Exhibitor for all risks that according to the independent assessment of the Exhibitor are not guaranteed or exceed the cover limits mentioned in the previous item. The Exhibitor himself must provide for appropriate supplementary cover.

Because of the halls video-controlling system, in case of thefts Exhibitors must present a written report draft by the Public Authority to the Insurance Company within seven days after the end of the exhibition. In default, there might occur the loss of the allowance. In order to request supplementary cover on his own initiative and at his own expense, if necessary, the Exhibitor can use the form included in the Various Forms Folder even during the exhibition and apply to the Insurance Company in the Exhibition Centre. The Insurance Company will also see to the management of accidents and liquidation procedures at the end of the exhibition on the conditions specified in the above form, and to the extent of the covers provided, it waives any claims for compensation against all Exhibitors, the Organizer, and BolognaFiere. In any case the Exhibitor undertakes to include in the supplementary cover the insurer's waiver of any claim for compensation against Exhibitors, the Organizer, or BolognaFiere, and failing this, he undertakes to hold them harmless against any action against them.

Having taken note of the above, the Exhibitor in any case (for himself and for his collaborators and appointees) expressly relieves the Organizer and BolognaFiere of any liability for losses or damages that may for any reason occur in the appointed exhibition space while setting up or dismantling the stand, and for the objects on the stand, and he takes upon himself the liability for any damage caused to third parties by the management of the exhibition space and of what is brought into it, and not covered by the terms and conditions of the policies subscribed by the Exhibitor as indicated above.

**Art. 13 - INTELLECTUAL PROPERTY** - It is prohibited to reproduce by photographs, drawings, or in any other way both the exhibited products and goods and the stands hosting them without the authorisation of the Exhibitor and the Organizer. The Organizer and BolognaFiere however reserve the right to film, reproduce, diffuse, and authorise the filming, reproduction, and diffusion of internal and external general and detailed views, and allow their sale or even sell them themselves.

**Art. 14 - TEMPORARY IMPORT** - The temporary import from abroad of commodities or goods to be exhibited, such as samples for the exhibition, must be made - at the expense of the Exhibitor - through the official shipping agent of BolognaFiere according to the modalities set out in the "Exhibition Technical Regulations", and free from any liability for actions of the shipping agent also as far as BolognaFiere is concerned.

**Art. 15 - EXHIBITION OF OPERATING MACHINERY** - The exhibited machinery may not be operated unless a written exceptional authorisation by BolognaFiere Operations Division and provided that it does not cause any danger or disturbance. In such an event, the machinery must be provided with special devices for the prevention of accidents, disturbing noise, bad odours, or the emission of gases and liquids; inside the halls, the machine may not be powered by internal combustion engines in operation and must not involve the use of fuel or gas bottles. In any case they must conform to the laws, regulations, and good practice techniques, and must be provided with the relevant administrative documentation by the competent authorities. The Exhibitor takes exclusively upon himself all tort and criminal liability for any accidents and/or damage that might be caused to third parties as a consequence of non-compliance with and breach of the regulations and/or verbal indications.

All the above subject to the right of BolognaFiere to take direct action to remove or to order the removal from the Exhibition Centre any structures not complying with the above provisions.

**Art. 16 - TECHNICAL SUPPLIES AND SERVICES** - On the Exhibitors' request, according to the provisions contained in the "Exhibition Technical Regulations and Various Forms Folder", BolognaFiere shall provide Exhibitors with electricity both for lighting and for motive power, as well as a connection to the water distribution network and compressed air. Moreover, BolognaFiere reserves the right to activate, or contract out, or give exclusive rights for, any service that might deem useful for the participants, and to establish the mode of service delivery. In particular:

- connections between the electric or water systems built by Exhibitors and the junction boxes and water outlets - respectively - can only be made by firms authorised by BolognaFiere, who will guarantee the observance of the regulations contained in the "Exhibition Technical Regulations and Various Forms Folder"
- the stand daily cleaning service is included in the cost of the unfurnished area: further requests must be carried out either at the care and cost of the Exhibitors with their own personnel or through the firm specifically authorised by BolognaFiere;
- connections for telephone sets can only be made by the supplier authorised by BolognaFiere;
- as regards all operations of portage, transport, goods loading and unloading inside the Exhibition Centre, if the Exhibitors do not avail themselves of their own means and personnel, they must exclusively make use of the official BolognaFiere forwarding agent;
- access to the stands is only allowed to vehicles equipped with anti-pollution systems.

The Exhibitor takes due note that the "services" (managed by BolognaFiere, contracted out or granted exclusively) are delivered regularly within the reasonable limits of normal use, and in any case, the Exhibitor shall hold BolognaFiere, the contractors, and concessionaires of the said services harmless from any liability in the event of irregularities in the service.

**Art. 17 - PRINTED AND ON-LINE INFORMATION** - Without any liability for omissions or errors, the Organizer shall arrange the diffusion (which may consist of summarized) information contained in the application form for participation regarding Exhibitors and/or the exhibited products and services, by the means and communication techniques that he deems most appropriate. The information will be referred to registrations received and accepted up to 45 days before the opening date of the event. All this without any prejudice for the Organizer's right to change the allotment of stands in accordance with these regulations. Likewise, the Organizer is not responsible for the contents of any other information forms signed by the Exhibitor or by its agent and made available by the Organizer, including via computer.

**Art. 18 - ADVERTISING** - Any kind of publicity and advertising outside the allotted exhibition area must be made exclusively through the Organizer or BolognaFiere concessionaires and is subject to payment of a fee and tax charges.

**Art. 19 - PARKING** - Only vehicles displaying a special badge are allowed to access the Exhibition car parks (subject to available slots), and they will only be allowed to park in the specially provided slots and during the opening hours of the Exhibition Centre. In the event of non-compliance with these provisions, BolognaFiere or the Organizer can have the vehicle towed out of the Exhibition Centre at the risk and expense of the Exhibitor holder of the badge and of the owner of the vehicle. Each occupant of such vehicles must have a document allowing access to the Exhibition Centre. Because the car parks are not attended, BolognaFiere and the Organizer are exempt from any liability in connection with the custody of the vehicle, and shall not be considered liable for damages or for thefts of any kind.

**Art. 20 - SPECIFIC PROHIBITIONS** - During the event, exhibitors are prohibited from:

- selling any of the exhibited goods and objects on immediate delivery terms and on the spot, except in those sectors where permission has been given by the Organizer;
- displaying prices, except in those sectors where permission has been given by the Organizer;
- transferring or even partially transferring or exchanging or even partially exchanging the stand;
- advertising in any form outside their own stand and in the Exhibition Centre. The distribution of advertising material is allowed only in their own exhibition area;
- exhibiting products not included in the marketing sector of the stand as specified on the application form for participation; exposure of products other than those stated in the application form will entail the immediate closure of the stand;
- exhibiting signs or samples, even simply as an indication, on behalf of firms not listed in the application form or not represented and for which ones the Exhibitor has not paid the Registration Fee (see Art. 3) to the Organizer;
- engaging in entertainment or show activities of any kind, nature, or description, even inside the stand or aimed at presenting products, without the authorisation by the Management of BolognaFiere.

Prohibitions of a technical nature for security, hygiene, or pollution reasons and, in general, for persons and things safety, or intended to prevent the alteration of movables or immovables inside the Exhibition Centre, and the regulations on this matter contained in the "Exhibition Technical Regulations and Various Forms Folder" are to be considered part and parcel of these regulations, which the Exhibitor undertakes to accept and strictly respect by signing. Any waiver to the above prohibitions must be issued exclusively in writing by the BolognaFiere Operations Division and shall be uniquely at the Exhibitor's expense and liability. In the event of non-compliance even with only one of the above-indicated prohibitions, or those recalled by this article, the Organizer may enforce the sanctions provided for by the "Exhibition Technical Regulations and Various Forms Folder" and/or terminate the contract of participation to the Exhibition without it being necessary to have a ruling issued by a Judge but simply by sending a written notice to the Exhibitor at his stand. This implies immediate closure of the stand and withdrawal of the documents of access to the Exhibition Centre, without any prejudice to the payments still due by the Exhibitor.

**Art. 21 - POSTPONEMENT, REDUCTION, OR SUPPRESSION OF THE EXHIBITION** - It is the discretionary and unquestionable right of the Organizer to change the dates of the exhibition, without by this entitling the Exhibitor to redecide or in any case terminate this contract and commitments. Up to 30 days before the beginning of the event, the Organizer is entitled to reduce or cancel altogether the exhibition totally or in part, by sending a written notice to the Exhibitors without being bound to pay a penalty or damages of any kind.

**Art. 22 - GENERAL PROVISIONS - DOMICILIATION - APPLICABLE LAWS - ITALIAN JURISDICTION AND TERRITORIALITY**  
**COMPETENT COURT** - The Exhibitor is obliged to comply with the prescriptions that may be issued to BolognaFiere by the Authorities, and by consent in charge of fire prevention, accident prevention, and surveillance of public premises. All the Exhibitor's rights exist solely and exclusively with regard to the Organizer, while each and every obligation of behaviour accepted by the Exhibitor shall be construed as applying also by extension to BolognaFiere, which shall thus be entitled, in the case of failure to comply with such obligations, with any regulation issued by itself and with any provision of law, to take direct action, taking steps also by means of its own service staff in the Exhibition Centre.
